

ASDA Tickled Pink Ball Event Terms and Conditions

Thank you for booking a place at the ASDA Tickled Pink Ball (the "Event"):

The following terms and conditions apply to this booking:

Payment and confirmation of booking

When you book to attend the Event, GroceryAid will issue you with an invoice on behalf of ASDA Stores Limited. Payment is due within 30 days of the invoice, or such shorter period as GroceryAid may specify if you book less than 30 days before the event. Your booking and place at the event will be confirmed only upon payment of the full amount. If you do not pay by the due date for payment your booking will be cancelled, but you may still be liable for some or all of the payment under the following provision.

Cancellation of booking and non-payment

If you wish to cancel your booking you must notify the GroceryAid events team: events@groceryaid.org.uk. GroceryAid will confirm your cancellation in writing and send you an invoice for any outstanding payments due.

Standard bookings

The following charges will apply if you cancel a standard booking, or if you do not pay for your booking by the due date for payment:

- If within 6 weeks of the event you cancel or have not paid for your booking by the due date for payment, you will not be entitled to any refund and, if you have not paid, you must pay the outstanding amount within 7 days but you will not be entitled to attend the event;
- If within 12 weeks of the event you cancel or have not paid for your booking by the due date for payment, you will be entitled to a refund of 50% of the total price if you have already paid in full or, if you have not already paid in full, you must pay 50% of the outstanding amount within 7 days; and
- If more than 12 weeks before the event you cancel you will be entitled to a full refund of any
 payment you have already made and if you have not paid you will not be obliged to make a
 payment.

You will not be entitled to a refund if you are unable to attend the event for any reason, except under the last two of the above provisions if they apply.

You acknowledge that any refund of your fees in accordance with this provision is your sole remedy in respect of any cancellation of your registration by you or if you have not paid by the payment due date and GroceryAid excludes any other liability.

Sponsorship or Activation bookings

If you make a sponsorship or activation booking, the following charges will apply if you cancel your booking or if you do not pay for your booking by the due date for payment:

If within 12 weeks of the you cancel or have not paid for your booking by the due date for payment, you will not be entitled to any refund and, if you have not paid, you must pay the outstanding amount within 7 days but you will not be entitled to attend the event;

If within 16 weeks of the event you cancel or have not paid for your booking by the due date for payment, you will be entitled to a refund of 50% of the total price if you have already paid in full or, if you have not already paid in full, you must pay 50% of the outstanding amount within 7 days; and

If more than 16 weeks before the event you cancel you will be entitled to a full refund of any payment you have already made and if you have not paid you will not be obliged to make a payment.

You will not be entitled to a refund if you are unable to attend the event for any reason, except under the last two of the above provisions if they apply.



You acknowledge that any refund of fees paid by you in accordance with this provision is your sole remedy in respect of any cancellation of your registration by you or if you have not paid by the payment due date and GroceryAid excludes any other liability.

Substitutions

Substitutions of event attendees may be made with employees from your organisation at any time. You must email events@groceryAid.org.uk with the name and contact details of any substitution promptly before the event.

Cancellation or postponement of the event

For the purpose of this provision, a force majeure event means any event that is beyond the reasonable control of GroceryAid or ASDA, including (without limitation) supplier or contractor failure, venue damage or cancellation, health scares, epidemics, speaker or performer or entertainer cancellation, failure or problems with public utility supplies, failure of computer equipment, withdrawal of sponsor or partner, industrial dispute, national emergency, governmental regulations or action, military action, fire, flood, disaster, civil riot, acts of terrorism or war.

ASDA may at its discretion change the date or cancel an event at any time for any reason. Where ASDA changes the date or cancels an event for any reason except due to a force majeure event, ASDA shall offer you the option of attending any rearranged event that at its discretion chooses to organise. If you promptly notify GroceryAid in writing to events@groceryAid.org.uk before the date of the cancelled or rearranged event that you do not wish to attend the rearranged event, or if ASDA decides not to rearrange the event, you will as your sole remedy be entitled to receive a refund of all payments you have made to GroceryAid to attend the Event.

Where a force majeure event has or may have in ASDA's discretion an adverse impact on the ability of ASDA to hold the event at the planned venue or on the planned date, or the event generally, ASDA shall be entitled but not obliged to provide an alternative venue for the event and/or reschedule the event. Any payment received by GroceryAid from you for the event shall be applied to any rescheduled event, but you will not be entitled to a refund if the event is moved to an alternative venue, rescheduled or cancelled.

To the fullest extent permitted by law, GroceryAid and ASDA shall not be liable to you for any loss, delay, damage or other lability incurred resulting from or arising in connection with the cancellation or date change of the event howsoever arising or any venue change.

Fitness to participate

You acknowledge that participation in the Event is at your own risk and, to the fullest extent possible in law, you will not hold GroceryAid or ASDA responsible for any accident, injury, or illness that you sustain.

Photography

ASDA may arrange for group photographs and/or video footage to be taken at events and used for promotional purposes by either ASDA, Ticked Pink or GroceryAid. This may include printed documents or media, editorial coverage, advertising press, and use on the internet. By submitting registration details, attendees agree that their image may be used in this manner. If you do not wish to be included in photographs or video footage, please speak to a member of ASDA's team when you arrive at the event. We will make reasonable endeavours to obtain specific consent from you if you are the main subject of an image or video footage.

How we collect and process personal data

GroceryAid is the controller and is responsible for your personal data, which will be processed in accordance with our privacy policy

We will collect, use, store and transfer your personal data (e.g. your name, email address, dietary requirements), as required for the organisation and administration of the event. Your name and



company will be placed on the attendee list for this event and this list may be provided to all attendees for them to see who is at the event for the purpose of networking and meetings.

When you make a booking with us, or express an interest in booking one of our events, we will add you to our mailing list so that we can send you emails about Tickled Pink or GroceryAid events in the future. If you do not wish to be added to our mailing list, you can email events@groceryaid.org.uk or unsubscribe at any time by clicking the unsubscribe link in the relevant email communication.

Refusal of admission

No attendee will be admitted to the event without a valid ticket. ASDA may at its discretion refuse admission or require an attendee to leave if the attendee, in the reasonable opinion of ASDA or its agents, behaves in a way which may affect the smooth running of the event, the enjoyment of other attendees, and/or the safety of any person. In these circumstances the attendee will not be entitled to a refund.

Unless an event is specifically advertised as being open to under 18s, ASDA will not admit anyone under the age of 18 to its event. We reserve the right to ask to see proof of age on entry and to refuse admission to an event if you are unable to provide proof of age that is satisfactory to ASDA. If you are refused admission in these circumstances, you will not be entitled to a refund.

Speakers, performers and entertainers

ASDA may at its discretion change the format, the appearances of any speakers, performers or entertainers advertised as attending the event, the venue location and programme or any other aspect of the event, for any reason and without liability.

Auctions

If you take part in an auction or raffle at the event, you agree to abide by any rules issued to you at the Event which apply to the auction.

Food allergies, intolerances and preferences

It is the responsibility of the person making a booking to notify us of any food allergies, intolerances or preferences prior to the event.

Exclusion of liability

To the fullest extent permitted by law, GroceryAid, ASDA and Tickled Pink excludes all liability for loss, injury or damage to persons or property at the event and any indirect or consequential loss. If GroceryAid, ASDA and Tickled Pink is liable to you for any reason, the total liability to you in relation to the event is limited to the amount of your fees received by GroceryAid.
